### LESSON

#### 1. Right to withdraw from the purchase agreement

You have the right to withdraw from this purchase agreement without providing a reason within 14 days of receiving the goods. The agreement's withdrawal period expires 14 days from the day when you or a third party designated by you, with the exception of the carrier, takes over the goods. The purchase agreement's withdrawal period is maintained if you send a notice to exercise the right to withdraw from the purchase agreement before the expiry of the purchase agreement's withdrawal period.

#### 2. Consequences of withdrawal

In the event of withdrawal from the purchase agreement, we will refund all payments you have made in connection with the conclusion of the purchase agreement, particularly the purchase price, including the cost of delivering the goods to you. This does not apply to additional costs if you have chosen a different type of delivery than the cheapest standard delivery method we offer, nor to the costs of additional services, if they have been the subject of an agreement and if they have been fully provided. **Payments will be returned** to you without undue delay and in any case **no later than 14 days** from the date on which we receive your withdrawal notice from this purchase agreement. The payment will be made in the same way as you used for your payment, unless you have given your consent to the payment to your bank account by entering your bank account's IBAN number, without charging any additional fees.

Payment for the purchased goods **will be paid to you only after goods have been returned** to our address or upon presentation of a document proving the return of the goods, whichever comes first. Return the goods to us or bring them to the company's registered address without undue delay and in any case **no later than 14 days from the date of exercising the right to withdraw from the agreement**. The direct costs of returning the goods are borne by you.

Please note that in the event of withdrawal from the purchase agreement, **you are legally responsible** for any reduction in the value of the goods due to handling in the period from delivery to the moment of return in a manner other than necessary to determine the nature, properties and functionality of the goods.
